Luncheon Reminder Mark Your Calendar

The 11th annual *Celebrating Lifelong Living Luncheon* fundraising event will be held September 19, 2013.

During 2012, Catholic Eldercare made significant strides to better serve seniors and their families.



Major Achievements

- Electronic Medical Records:** 2012 brought a quantum leap in data management. Catholic Eldercare transitioned from paper charts to an electronic health records system (EHR). Resident medical information is now entered into the EHR via laptop computers located on each floor of the nursing home. The new system operates in real-time so records are always up-to-date. Once fully implemented, it promises to be a major time-saver, substantially reducing daily paperwork so nurses can spend more time with the residents. It also prepares for the time when all health related records will be linked, providing for the efficient, secure sharing of health information with residents' doctors, labs, pharmacies, clinics and hospitals.
- Partnership with Northeast Meals on Wheels:** This nonprofit program faced an uncertain future until it moved to Catholic Eldercare to utilize kitchen facilities to prepare more than 600 meals per week for seniors and disabled clients in Northeast Minneapolis, Southeast Minneapolis, and St. Anthony Village. The collaborative sharing of expenses represents sound financial stewardship, and strengthens Catholic Eldercare's role as a comprehensive hub for senior services.
- In-Room Communion:** With the assistance of volunteers, in-room communion is available Monday through Friday for nursing home residents unable to attend church.
- St. Anthony of Padua:** In anticipation of the scheduled Archdiocesan closure of St. Anthony of Padua Church during summer 2013, Catholic Eldercare is working to ensure continuity of worship opportunities for residents.
- 2012 Celebrating Lifelong Living Luncheon:** This annual event, which inspires supporters to help fund programs important to residents, was attended by more than 500 guests who donated or pledged more than \$140,000 in charitable gifts and sponsorships.

The Prairie Dog Jug Band's Merry Music Making

Last spring, Catholic Eldercare music therapist Michael Limbybliw shared the seed of an idea with seniors who attend the Adult Day Program, and they've brought life to it in a profound way. Now, every Wednesday afternoon is rehearsal time for the Prairie Dogs Jug Band, an ensemble composed of 12-15 clients who had never given much thought to making music before.

"Too often older adults see life through the 'can't' lens. They may not be able to do some things as well as they once did," Michael says, "But the band helps them to emphasize their strengths and grow in new ways."

They *can* play in the band, and the rewards are great.



At a spring rehearsal, Michael counts off the beat as the Prairie Dogs launch into *She'll Be Coming Round the Mountain*, a group favorite. The band members' faces light up, their eyes focus on Michael as he leads on guitar. This is their jug band; they've found inside themselves the value of playing music together for a purpose - and it lights up the room.

"Music has huge value in reaching people, especially those with dementia," Michael explains. "It's all about reaching people, giving them a sense of purpose, and watching them grow. It's very fortifying for the clients, it gives them identity as part of something larger than themselves. The families love it because they're comforted seeing their loved ones contributing, doing something they never thought they could do."

None of the Prairie Dogs had any real musical experience until Michael became their encouraging, musical director, passing out instruments and introducing songs and melodies familiar to their generation.

"It's a lot of fun," exclaims Roz, as she gives her maracas a robust, rhythmic shake. In the first row, Russ plays one of the jugs. Ramona handles a drum, Judy is on cymbals. Other band members play the harmonica, washboard, the washtub bass, spoons, djembe, tubano, tambourine, cabasa, maracas, bongos, triangles and kazoos. Michael carries the melody with his guitar and voice. "And Bruce over there, whistles really well," Michael says as he points out a smiling face in the band.

Staff members are granted honorary membership status in the Jug Band as performers and fans. CEO Dan Johnson sat in during a rehearsal, contributing some spirited harmonica action.

Feeding the Spirit

While the jug band offers great fun and socialization for the clients, there is abundant wisdom behind this therapeutic approach. Band participation helps to build self-esteem because the seniors are actively accomplishing something new. Music enhances cognition, lighting up the brain with new neural pathways stimulated by sound and beat. The jug band creates a community, with seniors performing a public service by sharing the music with others. The Prairie Dogs perform widely throughout the Twin Cities and have brought home several awards for their musical achievements, including a Best of Show trophy from a jug band competition.

The first rhythm that one experiences is the mother's comforting heartbeat. Now, in the autumn of life, these seniors are experiencing a profound truth: music is given by God to further His purposes. And the songs and rhythms mellow the souls of those who play and listen.

Movement, Music & Fun

Renee McHugh's first job at age 16 was in the dietary department of a nursing home. Later came the 'in between' years when she worked as a postal carrier and a public safety/media officer for the Golden Valley Police Department. Then, she felt the tug again and it was back to senior care at Benedictine Health Center at Innsbruck where she served as the Activity Coordinator and Wellness Coach.

Now, Renee brings an abundance of enthusiasm, creativity and really cool percussion skills to her new position as Catholic Eldercare's Therapeutic Recreation Director. "I am so honored and excited to be part of Catholic Eldercare. I'm so impressed with the staff, and the faces of residents just light up when they're involved in this fabulous program. I love it."

Renee's sensitivity for the needs of elders was formed by her own family experiences. "I watched my grandparents and parents age and realized it should be the best possible experience it can be," she says. "We can keep learning, be part of the community, and feel useful regardless of age."

Passion for Wellness and Music

In her previous position, Renee incorporated a wellness philosophy into her program with phenomenal outcomes. "Residents increased their balance and flexibility, which enhanced overall well-being and reduced the risk of falling. There's value in being more flexible and agile, to be able to brush your hair again or to put an arm in a sleeve, to regain control that you had previously lost."

"The residents loved moving, feeling good and becoming more fit. Aging is a gradual process, but we can maintain and even improve mobility and strength."

A dedicated percussionist, Renee understands the power of music and rhythm to reach older adults, especially those who have turned inward and are struggling. "One man was in the final stages of life and sleeping most of the time. When I played music for him, he squeezed my hand, opened his eyes and started singing the song. There was a real spark," she says with a smile.

Giving Where Your Heart Is

Volunteers David and Phyllis Robinson hurry into the warm RiverVillage lobby on a brutally cold day before their volunteer shift begins. They grab a cup of coffee and share with a visitor their love of serving others. "We've been volunteering since we were first married," David explains. "We've always liked staying involved and helping however we can."

When RiverVillage opened in 2004, the Robinsons saw a notice in the St. Hedwig church bulletin about volunteers needed to staff the senior care facility's coffee shop. They felt like it was a good cause and promptly signed up. Phyllis had previously worked in a senior care facility and she understood the importance of volunteers to break through the loneliness and isolation so common among older adults.

The Hands of Jesus

Making the day brighter is always a worthy goal. Every Wednesday, the Robinsons serve communion to nursing home residents who are unable to attend Mass or other worship services. Then, the Robinsons drive to RiverVillage to help with shopping excursions, assisting residents as they board the bus and, later, with their shopping at the various retail stores. "It's always fun talking with our friends, helping and encouraging them," Phyllis says. "It's great knowing we make a difference. They're always so grateful and thank us."

"We get satisfaction out of helping others," David adds. "Some residents don't have many visitors so they need to see a friendly smile regularly. It gives us pleasure to see their smiles."

During the holiday season at RiverVillage, you can see David and Phyllis in their starring roles, decked out in red and white, as Mr. and Mrs. Claus.

And the Robinsons quickly discovered how Catholic Eldercare is a microcosm of Northeast, a community bound together by friendships and memories. One day, while walking down the hallway, they met Sister Jean Thuerauf, the founder of the nonprofit Cookie Cart. "I know you," Sister Jean exclaimed, extending a hand and warm smile to the Robinsons. "I worked with Sister Jean when she first started the Cookie Cart," David explains, "A friend and I built a little chapel in her house on the north side. It was so nice to see her again."

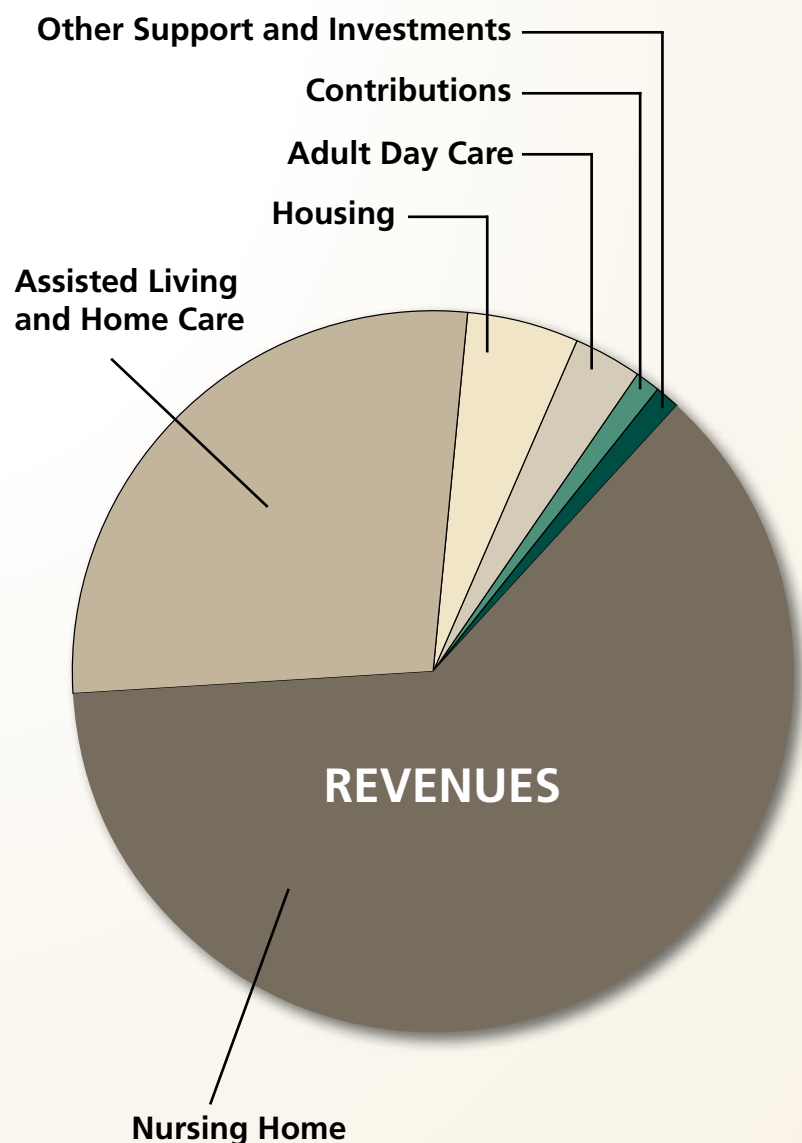
